vanderLinde Park – Trustee Campbell asked Joe Benedict when the newly acquired playground equipment would be installed. Joe indicated that he doesn't have a plan for the layout of the equipment. It was decided that Trustee Campbell would meet with Joe Benedict on Tuesday afternoon at 3:00pm to discuss a plan.

Trustee Sullivan wanted to discuss where the village was with Hawkins Rides Mr. Hawkins has concerns about the Village putting conditions on his request. It was decided that Joe Benedict would talk to Hawkins and let him know he is welcome here but only 2 of the 3 suggestions, he can bring 6 rides and either the concessions or games not both. The consensus is to not have any duplication of what is currently being offered by the Sylvan Beach Amusement Park. Mayor Horan will call and talk to Doug Waterbury.

New Business:

Mayor would like to reduce the number of members on the Planning Board from a seven member board to a five member board. Village Board will need to schedule a public hearing to change current local law.

Muni Bids for new pickup for DPW- this was tabled until the next meeting when Dan Lehmann the DPW Working Supervisor could attend. The Mayor would also like everyone to think about just buying the truck and not financing it.

Public Works Superintendant and Village Administrator Position, the Mayor would like to separate these positions and place Joseph Benedict as the Village Administrator and leave the Public Works Superintendant position vacant at this time. The payroll would need to be transferred from the DPW payroll to the Village Administrators payroll at \$24.63 hourly and benefits as he is currently receiving all future pay increases and benefits will be reviewed by the Mayor and the Board yearly. This position is also a yearly appointment by the Mayor.

Motion was made by Trustee Clements and seconded by Trustee Campbell authorizing the Mayor to separate the position of Public Works Superintendant and Village Administrator and to appoint Joseph Benedict as the Village Administrator with the Public Works Superintendant position vacant. Also the board authorizes the Village Clerk to transfer the payroll at \$24.63 hourly from the DPW payroll to the payroll for Village Administrator and benefits as currently receiving all future pay increases and benefits will be reviewed by the Mayor and the Board yearly with a yearly appointment made by the Mayor. William DeFazio presented the board with price quotes for several items needed at the treatment plant.

He had a price for 4 roofs to be repaired by Henderson with the average cost of \$14,550 and 1 roof at \$15,885. Bill wanted to use Henderson as he has replaced other roofs and he would like to keep them the same. The board discussed and felt this should go out to bid.

Motion was made by Trustee Clements and seconded by Trustee Shaughnessy to put out to bid the replacement of roofs for 4 pump stations, in order to stay within the guidelines of the procurement policy. Carried as follows

Bill also requested 3 gear boxes and motor at \$1729 each. Bill indicated that he had received 3 quotes Mayor asked that he bring them to the next meeting.

Next Bill wants to replace some of the lighting at the plant and had pricing from Graingers who has state contract. There are 3 different types it was asked why Bill wasn't going LED and Bill explained that for some reason the LEDs do not work at the plant and he has had to replace them so they are not cost efficient. Joe Benedict would like to know why they are not working.

Motion was made by Trustee Clements and seconded by Trustee Sullivan to allow Bill to purchase the light fixtures as quoted by Grainer for a total cost of \$16,523.11. Carried as follows:
